I accept for use the equipment listed on this form and accept full responsibility for the care of this equipment. I understand that bicycling is a hazardous activity.

I understand that the sport of bicycling and the use of this equipment involve a risk of injury to any and all parts of the user's body. I hereby agree to freely and expressly assume and accept any risks and all injury to the user of this equipment while bicycling. I understand that bicycle protective gear such as helmets and gloves are recommended, but they do not eliminate the risk and may not reduce the risk of injury in the event of an accident. I agree that I will release this bicycle shop from any and all responsibility of liability for injuries or damages to the user of the equipment listed on this form or to any other person.

I agree not to make a claim against or sue this bicycle shop for injuries or damages relating to bicycling or the use of this equipment. The equipment, at all times, remains the exclusive property of the bicycle shop. The renter is responsible for damage to or loss of the equipment. If the equipment is lost, stolen, destroyed or damaged beyond repair in the judgment of the bicycle shop, the renter agrees to pay the bicycle shop the value of the bicycle. All equipment repairs, needed as a result of its use, will be performed at the normal labor rates and the renter shall pay the cost of such repairs, including all parts.

I hereby accept the terms of this contract. This document constitutes the final and entire agreement between this bicycle shop and the undersigned. This bicycle shop itself provides no warranties express or implied, and this equipment is accepted "as is." I have carefully read this agreement and release of liability and fully understand its contents. I am aware that this is a release of liability and a contract between this bicycle shop and myself and I sign it of my own free will.
